Why did you select SUTD for your postgraduate studies, and what distinguished it from other options?

SUTD provided a unique multidisciplinary learning environment during my undergraduate studies, particularly through our design projects*. The integration of architecture and robotic engineering at SUTD allowed me to deeply engage in research on robot ergonomics. This experience offered valuable insights into developing spaces that are inclusive of robotic systems. I am very fortunate to have Associate Professor Mohan Rajesh Elara, a leader in the field of robotics, as my PhD advisor and my research topic was closely related to some of his work.

Other universities would focus on either specialisation or have limited resources for the specific industry. This would not have enabled the wider access to robots or zones for deployment and testing as I had in SUTD.

*Design experiences are incorporated within and outside the SUTD curriculum - within subjects, cutting across subjects, across academic years and projects driven by students.

What opportunities or changes did you experience after completing your PhD?

I have unique opportunities and access to both the architecture and robotics industries, allowing me to apply niche insights that other graduates may not possess. In terms of robotics engineering, I am now able to provide robotic deployment knowledge in architectural zones. With my Master of Architecture experience, I am well placed to provide architectural insights on how zones can be improved for robot productivity, such as area coverage (e.g. robotic cleaning operations), or optimised waypoint navigation for the highest visual coverage (e.g. robotic security/surveillance).

I completed my bachelor's degree at California State University but pursuing the Master of Science in Technology and Design (MTD) at SUTD has truly redefined my educational experience. 


